CODE OF CONDUCT**

The following behaviors are strictly prohibited at, or on GYCC premises. Any participant, volunteer or staff member who violates this Code is subject to disciplinary action, including removal from the program.

1. Abusive or disrespectful language towards a staff member, volunteer or another participant.
2. Possession or use of alcoholic beverages or illegal drugs on GYCC property, or reporting to the program while under the influence of drugs or alcohol.
3. Bringing dangerous or unauthorized materials onto GYCC property such as explosives, firearms, weapons or similar items.
4. Discourtesy or rudeness to a fellow participant, staff member or volunteer.
5. Verbal, physical or visual harassment of another participant, staff member or volunteer.
6. Actual or threatened violence toward any individual or group.
7. Conduct endangering the life, safety, health or well-being of others.
8. Failure to follow any GYCC policies or procedures.
9. Bullying or taking unfair advantage of any participant.
10. Failing to cooperate with an adult supervisor, leader or mentor.
11. Inappropriate and/or disrespectful use of technology including the internet and mobile devices.
